



# WARRANTY CONDITIONS

## LEXAN™ CLINIWALL™ SHEET C6200

### 10 YEAR LIMITED WRITTEN WARRANTY

LEXAN CLINIWALL C6200 sheets will not break due to loss of impact strength when used indoors within ten (10) years of the date of sale by SABIC.

This limited written warranty is subject to the following conditions:

1. This limited written warranty applies exclusively to C6200 sheet opaque produced by SABIC in Europe in all available colors used correctly as flat, curved or formed sheet, handled, stored, processed, installed and maintained according to SABIC recommendations.
2. This limited written warranty does not apply to sheet that has been scratched, abraded or exposed to corrosive materials or chemicals.
3. This limited written warranty is given only to the original purchaser of SABIC sheet and does not extend to any subsequent purchaser or transferee. Any warranty claim hereunder must be made immediately within the warranty period by specifying the claim in writing and submitting to SABIC the original sales receipt which must contain the name and address of the purchaser, the date of purchase, the complete product name, the lot number and the volume purchased. On request of SABIC claimant must allow the material to be inspected on site and/or return the sheet to SABIC for testing.
4. For the purpose of this limited written warranty: Mechanical properties after 10 years:
  - a. The modulus of elasticity will be  $\geq 2100$  MPa. The elastic modulus is measured in the tensile test according ISO 527.
  - b. The tensile strength will be  $\geq 55$  MPa. The tensile strength is measured in the tensile test according ISO 527.
5. SABIC reserves the right to investigate independently the cause of any failure. If a claim under this limited written warranty is justified, SABIC will provide the purchaser with

replacement material free of charge in accordance with the following schedule:

Time from Orig. Purchase Date	Material Replacement
Up to 5 years	100%
in 6th year	75%
in 7th year	60%
in 8th year	45%
in 9th year	30%
in 10th year	15%

If replacement material cannot be provided within a reasonable period of time, SABIC may opt to refund the original purchase price paid to SABIC, or a portion thereof, in accordance with the above schedule.

6. This limited written warranty shall be SABIC's sole liability and customer's exclusive remedy for the products and all other claims for damages are excluded. This limited written warranty is in lieu of all other warranties (except of title), written or oral, statutory, express or implied, including any warranty of merchantability or fitness of purpose. This warranty shall be governed by the laws of the Netherlands.
7. This limited written warranty has been issued on August 1<sup>st</sup>, 2019 and is restricted to C6200 material sold by SABIC after such date end supersedes all previously issued warranties for C6200 sheet, sold after said date. The validity of this limited written warranty is restricted to C6200 sheet, and this limited written warranty is the sole warranty for C6200 sheet.
